


# Notes regarding the operating manual

# **Symbols**



## **Warning of electrical voltage**

This symbol indicates dangers to the life and health of persons due to electrical voltage.



## Warning of hot surface

This symbol indicates dangers to the life and health of persons due to hot surface.



#### Warning

This signal word indicates a hazard with an average risk level which, if not avoided, can result in serious injury or death.



#### **Caution**

This signal word indicates a hazard with a low risk level which, if not avoided, can result in minor or moderate injury.

#### **Note**

This signal word indicates important information (e.g. material damage), but does not indicate hazards.



#### Info

Information marked with this symbol helps you to carry out your tasks quickly and safely.



#### Follow the manual

Information marked with this symbol indicates that the operating manual must be observed.

# Safety

Read this manual carefully before starting or using the device. Always store the manual in the immediate vicinity of the device or its site of use.



## **Warning**

## Read all safety warnings and all instructions.

Failure to follow the warnings and instructions may result in electric shock, fire and/or serious injury. Save all warnings and instructions for future reference.

This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved. Children shall not play with the appliance. Cleaning and user maintenance shall not be made by children without supervision.



## Warning

Children of less than 3 years should be kept away from the device unless continuously supervised.

Children aged from 3 years and less than 8 years shall only switch on/off the appliance provided that it has been placed or installed in its intended normal operating position and they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.

Children aged from 3 years and less than 8 years shall not plug in, regulate and clean the appliance or perform user maintenance.





## Warning

Do not use the device in small rooms if persons are present who cannot leave the room independently and who are not under constant supervision.

- Do not use the device in potentially explosive rooms or areas and do not install it there.
- Do not use the device in aggressive atmosphere.
- Let the device dry out after a wet clean. Do not operate it when wet.
- Do not use the device with wet or damp hands.
- Do not expose the device to directly squirting water.
- Never insert any objects or limbs into the device.
- Do not use the device as source of ignition.
- Do not cover the device during operation.
- Do not sit on the device.
- This appliance is not a toy. Keep away from children and animals. Do not leave the device unattended during operation.
- Check accessories and connection parts for possible damage prior to every use of the device. Do not use any defective devices or device parts.
- Ensure that all electric cables outside of the device are protected from damage (e.g. caused by animals). Never use the device if electric cables or the power connection are damaged!
- The mains connection must correspond to the specifications in the Technical annex.
- Insert the mains plug into a properly fused mains socket.
- Observe the device's power input, cable length and intended use when selecting extensions to the power cable. Completely unroll extension cables. Avoid electrical overload.
- Before carrying out maintenance, care or repair work on the device, remove the mains plug from the mains socket.
   Hold onto the mains plug while doing so.
- Switch the device off and disconnect the power cable from the mains socket when the device is not in use.
- Do not under any circumstances use the device if you detect damages on the mains plug or power cable.
   If the power cable is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.
   Defective power cables pose a serious health risk!
- When installing the device, observe the minimum distances from walls and other objects as well as the storage and operating conditions according to the technical data (chapter Technical annex).

- Keep a safety distance of at least 1 m between the device's radiator side and all combustible materials such as textiles, curtains, beds and sofas.
- Allow the device to cool down before transport and/or maintenance work.
- The device must not be positioned directly beneath a wall socket.
- The device must not be used with a programming switch, timer, separate remote control system or similar equipment that switches the device on automatically, as this could cause a fire hazard if the heater is covered or positioned incorrectly.
- Do not use the device if it has been dropped or if it shows visible signs of damage.



#### Intended use

Use the device for heating surfaces in roofed outdoor areas.

The device is only intended for floor installation.

Intended use comprises:

- heating surfaces
  - in storage facilities,
  - in construction areas,
  - in containers,
  - in roofed outdoor areas (e.g. covered terraces).

#### Foreseeable misuse

- The device is not intended for industrial use.
- Do not place the device on wet or flooded ground.
- Do not place any objects, e.g. clothing, on the device.
- Do not use the device for heating in vehicles.
- Do not use this device in the vicinity of fuel, solvents, varnishes or other easily inflammable vapours or in rooms where these substances are stored.
- The device may not be used as a heating device for babies / children or animals.
- Do not use the heating device in immediate proximity to swimming pools.
- Any use other than the intended use is regarded as a reasonably foreseeable misuse.

Any unauthorised changes, modifications or alterations to the device are forbidden.

## **Personnel qualifications**

People who use this device must:

- be aware of the dangers that occur when working with electric devices in damp areas.
- have read and understood the operating manual, especially the Safety chapter.

Maintenance tasks which require the housing to be opened must only be carried out by specialist electrical companies or by Trotec.

## Symbols on the device

Symbols	Meaning
	This symbol located on the device indicates that it is prohibited to place objects (such as towels, clothes etc.) above or directly in front of the device.  In order to avoid overheating and fire hazards, the heater must not be covered.

## **Warning of electrical voltage**

Work on the electrical components must only be carried out by an authorised specialist company!



## Warning of electrical voltage

Before any work on the device, remove the mains plug from the mains socket!

Do not touch the mains plug with wet or damp hands. Hold onto the mains plug while pulling the power cable out of the mains socket.



## Warning of electrical voltage

Risk of electric shock!

Risk of an electric shock if the heating device comes into contact with water in bathtubs, showers or swimming pools!

Do not use this heating device in immediate proximity to bathtubs, showers or swimming pools!



## Warning of hot surface

Parts of this appliance can become very hot and cause burns. Particular attention is to be paid when there are children or vulnerable persons present!



#### Warning

Improper handling entails a risk of burning and electric

Only use the device as intended!



#### Warning

Dangers can occur at the device when it is used by untrained people in an unprofessional or improper way! Observe the personnel qualifications!

The device is not a toy and does not belong in the hands of children.

Risk of suffocation!

Improper installation entails a risk of fire.

#### Warning

Risk of injury due to infrared radiation!

Do not stay in the device's immediate vicinity for too long. Do not look directly into the device for too long. Observe the minimum distances.





## Warning

In order to avoid overheating and fire hazards, the device must not be covered!



#### Warning

Coarse dirt particles on the heating rods can cause the device to overheat. Fire hazard!

Remove coarse dirt particles from the heating rods according to the Maintenance chapter before switching on the device.

# Behaviour in the event of an emergency

- 1. Switch the device off.
- 2. In an emergency, disconnect the device from the mains feed-in: Hold onto the mains plug while pulling the power cable out of the mains socket.
- 3. Do not reconnect a defective device to the mains.

## Tilt protection

The device comes equipped with a tilt protection. The tilt protection is a safety device intended to minimize the risk of fire in case the device is tipped over inadvertently. The device will be switched off when knocked over (or if its upright position is changed in any other manner).

The tilt protection switches the device off when it is inclined out of its vertical position. The device can again be used as usual only a few seconds after placing it back in vertical position and on solid ground.

## **Overheating protection**

The device is provided with a safety thermostat which is activated by overheating of the device (when exceeding the operating temperature).

Once the safety thermostat has switched itself on, the device will be turned off.

Wait for one hour, then switch the device on again.

If the safety thermostat does not switch in the event of overheating, the overheating protection will be tripped. In that case the device switches off completely. If so, please contact the customer service to have the overheating protection replaced.

## Information about the device

## **Device description**


The device IRS 2010 E is used to quickly generate instant heat.


The device is based on the functional principle of heat generation by infrared radiation. The infrared radiation is generated by a carbon heating element and emitted to the surrounding surfaces as heat radiation. Persons or objects are heated directly.


- Protection type IP44 splash-proof
- approx. 10,000 operating hours with a light reduction of 90 %
- silent operation
- no dust circulation (suitable for allergy sufferers)
- with tilt protection
- Timer function
- Two heating levels

# **Transport and storage**

#### Note

If you store or transport the device improperly, the device may be damaged.

Note the information regarding transport and storage of the device.

## **Transport**

To make the device easier to transport, it is fitted with a transport handle.

**Before** transporting the device, observe the following:

- Switch the device off.
- Hold onto the mains plug while pulling the power cable out of the mains socket.
- Do not use the power cable to drag the device.
- Allow the device to cool down sufficiently.

## **Storage**

**Before** storing the device, proceed as follows:

- Hold onto the mains plug while pulling the power cable out of the mains socket.
- Allow the device to cool down sufficiently.

When the device is not being used, observe the following storage conditions:

- dry and protected from frost and heat
- in an upright position where it is protected from dust and direct sunlight
- with a cover to protect it from invasive dust, if necessary
- Place no further devices or objects on top of the device to prevent it from being damaged.
- Remove batteries from the remote control.




# **Assembly and start-up**

# Scope of delivery

- 1 x device
- 1 x Remote control
- 1 x Foot
- 4 x Fixing screw for foot
- 1 x Hexagonal wrench
- 1 x Manual

# **Unpacking the device**

- 1. Open the cardboard box and take the device out.
- 2. Completely remove the packaging.
- 3. Remove the transport protection (8) from the grille of the radiant heater.



4. Fully unwind the power cable. Make sure that the power cable is not damaged and that you do not damage it during unwinding.

# Warning

There is a risk of fire if the required minimum distances are not observed.



## **Foot assembly**


- 1. Tighten the 4 screws for the foot (6) on the device using the hexagonal wrench.
- 2. Check the foot for tight fit.





## Installation

When installing the device, observe the minimum distances from walls and other objects as described in the Technical data chapter.



- Set the device up in an upright and stable position.
- Do not position the device directly below a wall socket.

## Start-up



#### Info

Odours might arise upon initial start-up or after a longer period of non-use.

- Before restarting the device, check the condition of the power cable. If there are doubts as to the sound condition, contact the customer service.
- Do not create tripping hazards when laying the power cable or other electric cables, especially when positioning the device in the middle of the room. Use cable bridges.
- Make sure that extension cables are completely unrolled.
- Make sure that there are no curtains or similar objects in the immediate vicinity.


Prior to initial start-up, insert batteries in the remote control.

## Connecting the power cable

- Insert the mains plug into a properly fused mains socket.
- Make sure that the power cable is guided along the back of the device. Never guide the power cable along the front of the device!

# **Operation**

## **Operating elements**




No.	Designation	Meaning
1	Segment display	Heating level indication:  L1 = heating capacity 1000 W  L2 = heating capacity 2000 W  Indication of the number of hours
9	<i>Power</i> button	during timer programming Switching the device on or off
10	Timer button	Timer function: Automatic switch-off in increments of 1 hour up to 24 hours
11	Heating level button	Changing the heating level



#### **Remote control**

All settings of the device can also be made using the remote control included in the scope of delivery.



No.	Designation	Meaning
9	<i>Power</i> button	Switching the device on or off
10	Timer button	Activate automatic switch-off timer function in increments of 1 h up to 24 h
11	Heating level button	Setting the heating level
12	UP button	Heating level/timer function Increases the value.
13	DOWN button	Heating level/timer function Reduces the value.



## Warning of hot surface

The grille (3) heats up during operation and can be warm after switch-off.

Do not touch the grille (3) during operation, wait until it has cooled down after switch-off.

## Switching the device on

Once you have completely installed the device as described in the chapter Assembly and start-up, you can switch it on.

- 1. Set the mains switch (5) to position I.
  - ⇒ The device is now in standby mode.
- 2. Press the *on/off* (9) button to switch the device on.
- 3. Press the *heating level* button (11) to select the desired heating level (L1 L2).
  - $\Rightarrow$  The segment display (1) indicates the set heating level.

## **Setting the timer**

The timer allows you to program an automatic switch-off time in increments of 1 hour up to 24 hours at any heating level.

#### **Automatic switch-off**

- ✓ The device is switched on.
- 1. Press the timer button (10) for several times to adjust the number of hours of the timer.
  - ⇒ The segment display (1) indicates the set number of hours.
  - ⇒ The timer has been programmed and the device will switch off after the predefined time.

Notes regarding automatic switch-off:

- Manually switching the device off disables the automatic switch-off function.
- If you select 00 hours, the timer will be switched off.

#### Shutdown



## **Warning of electrical voltage**

Do not touch the mains plug with wet or damp hands.

- Switch the device off by setting the mains switch (5) to position **0**.
- Allow the device to cool down completely.
- Hold onto the mains plug while pulling the power cable out of the mains socket.
- Clean the device according to the Maintenance chapter.
- Store the device according to the Transport and storage chapter.



# **Errors and faults**



## **Warning of electrical voltage**

Tasks which require the device to be opened must only be carried out by authorised specialist companies or by Trotec.

The device has been checked for proper functioning several times during production. If malfunctions occur nonetheless, check the device according to the following list.

#### The device does not start:

- Check the power connection.
- Check the power cable and mains plug for damage. If you notice damages, do not try to take the device back into operation.

If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.

- Check the on-site fusing.
- Check whether the device is standing upright and on level ground. The tilt protection may have been tripped owing to the fact that the device was knocked over. Always put up the device in an upright position on a suitable, sufficiently dimensioned surface.
- The overheating protection may have been tripped. Have a specialist electrical company or Trotec check the electrics and replace the overheating protection.
- Wait for 10 minutes before restarting the device. If the device is not starting, have the electrics checked by a specialist company or by Trotec.

#### The device does not emit heat:

- The heating element may be defective. If the heating element is defective, have it replaced by a specialist electrical company.
- Check the mains switch (5). If the switch is set to the 0 position, the device is switched off. Switch the device on. If the mains switch (5) is set to position I, check whether the device is in standby mode.

## RCD or another fuse trips:

- Check the fuse. Switch off any other devices to reduce the load on the line.
- Contact a specialist electrical company.

# The device slightly vibrates during switch-on and then stops vibrating:

Slight vibrations during switch-on are a normal process.
 No measures are required.

## The device does not respond to the infrared remote control:

- Check whether the distance between remote control and device is too large and reduce it if necessary.
- Make sure there are no obstacles, such as furniture or walls, between the device and the remote control. Ensure visual contact between device and remote control.
- Check the charging status of the batteries and change them if required.
- If the batteries have just been changed, check them for correct polarity.

# The device does not run and the display shows "E1":

- The device is overheating. Check the minimum distance from walls or other objects according to the technical data. Adjust the minimum distances.
- Wait for 10 minutes before restarting the device. If the device is not starting, have the electrics checked by a specialist company or by Trotec.

## The device does not run and the display shows "E2":

- The tilt protection has been activated. Set the device up in an upright position.
- Wait for 10 minutes before restarting the device. If the device is not starting, have the electrics checked by a specialist company or by Trotec.

#### Note

Wait for at least 3 minutes after maintenance and repair work. Only then switch the device back on.

# The device still does not operate correctly after these checks:

Please contact the customer service. If necessary, bring the device to an authorised specialist electrical company or to Trotec for repair.

# **Activities required before starting maintenance**



## Warning of electrical voltage

Do not touch the mains plug with wet or damp hands.

- Switch the device off.
- Hold onto the mains plug while pulling the power cable out of the mains socket.

# Cleaning the device



## Warning of electrical voltage

Never immerse the device in water!



# Warning of hot surface

Do not touch the reflector or the heating rods with bare hands.

Clean the device with a soft, damp and lint-free cloth. Ensure that no moisture enters the housing. Protect electrical components from moisture. Do not use any aggressive cleaning agents such as cleaning sprays, solvents, alcohol-based or abrasive cleaners to dampen the cloth.

Wipe the housing dry after cleaning.

Dirt on the heating rods should be removed with a long brush with soft bristles.
