# **Symbols**



#### **Warning of electrical voltage**

# Safety

Read this manual carefully before starting or using the device. Always store the manual in the immediate vicinity of the device or its site of use.



#### **Warning**

# Read all safety warnings and all instructions.

Failure to follow the warnings and instructions may result in electric shock, fire and/or serious injury.

Save all warnings and instructions for future reference.

This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.

Children shall not play with the appliance. Cleaning and user maintenance shall not be done by children without supervision.



## Warning

Children of less than 3 years should be kept away from the device unless continuously supervised.

Children aged from 3 years and less than 8 years shall only switch on/off the appliance provided that it has been placed or installed in its intended normal operating position and they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.

Children aged from 3 years and less than 8 years shall not plug in, regulate and clean the appliance or perform user maintenance.



#### Warning

Do not use the device in small rooms if persons are present who cannot leave the room independently and who are not under constant supervision.

- Let the device dry out after a wet clean. Do not operate it when wet.

- Do not cover the device during operation.
- Do not remove any safety signs, stickers or labels from the device. Keep all safety signs, stickers and labels in legible condition.
- Do not sit on the device.
- This appliance is not a toy. Keep away from children and animals.
- Check accessories and connection parts for possible damage prior to every use of the device. Do not use any defective devices or device parts.
- Ensure that all electric cables outside of the device are protected from damage (e.g. caused by animals). Never use the device if electric cables or the power connection are damaged!
- The mains connection must correspond to the specifications in the Technical annex.
- Insert the mains plug into a properly fused mains socket.
- Observe the device's power input, cable length and intended use when selecting extensions to the power cable. Completely unroll extension cables. Avoid electrical overload.
- Before carrying out maintenance, care or repair work on the device, remove the mains plug from the mains socket.
   Hold onto the mains plug while doing so.
- Switch the device off and disconnect the power cable from the mains socket when the device is not in use.
- Do not under any circumstances use the device if you detect damages on the mains plug or power cable.
   If the power cable is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.
  - Defective power cables pose a serious health risk!
- When installing the device, observe the minimum distances from walls and other objects as well as the storage and operating conditions according to the technical data (chapter Technical annex).
- Keep a safety distance of at least 1 m between the air inlet and the air outlet of the device and all combustible materials such as textiles, curtains, beds and sofas.

- Make sure that the air inlet and outlet are not obstructed.
- Make sure that the suction side is kept free of dirt and loose objects.
- Do not place the device on combustible ground.
- Only use original spare parts, for otherwise safe and functional operation cannot be ensured.
- Allow the device to cool down before transport and/or maintenance work.
- Do not use the device if it has been dropped or if it shows visible signs of damage.
- Use the CR 2032 button battery type.
- Do not insert rechargeable batteries into the remote control.
- Never charge batteries that cannot be recharged.
- Different types of batteries and new and used batteries must not be used together.
- Insert the batteries into the battery compartment according to the correct polarity.
- Remove discharged batteries. Batteries contain materials hazardous to the environment. Dispose of the batteries according to the national regulations.
- Remove the batteries from the remote control if you will not be using the device for a longer period of time.
- Never short-circuit the supply terminal in the battery compartment!
- Do not swallow batteries! If a battery is swallowed, it can cause severe internal burns within 2 hours! These burns can lead to death!
- If you think batteries might have been swallowed or otherwise entered the body, seek medical attention immediately!
- Keep new and used batteries and an open battery compartment away from children.
- If the battery compartment does not close securely, stop using the product via the remote control.



#### Intended use

The device is only suitable for well insulated spaces or occasional use.

The fan heater serves the purpose of heating and ventilating closed rooms. The device was designed for private usage and is not suited for commercial use. The device is particularly well suited for additional heating. The device is only intended for floor installation.

Any use other than the intended use is regarded as misuse.

# Reasonably foreseeable misuse

- Do not place the device on wet or flooded ground.
- Do not place any objects, e.g. clothing, on the device.
- Do not use this device in the vicinity of fuel, solvents, varnishes or other easily inflammable vapours or in rooms where these substances are stored.
- Do not use the device out of doors.
- Do not use the device for heating vehicles.
- Never immerse the device in water.
- Do not make any unauthorised modifications, alterations or structural changes to the device.
- Do not use the heating device in immediate vicinity of swimming pools, bathtubs and showers.

# Personnel qualification

People who use this device must:

- be aware of the dangers that occur when working with electric devices in damp areas.
- have read and understood the instructions, especially the Safety chapter.

Maintenance tasks which require the housing to be opened must only be carried out by specialist electrical companies or by the manufacturer.

# Symbols on the device

# This symbol located on the device indicates that it is prohibited to place objects (such as towels, clothes etc.) above or directly in front of the device. In order to avoid overheating and fire hazards, the heater must not be covered.

# **Overheating protection**

The device is provided with a safety thermostat which is activated by overheating of the device (when exceeding the operating temperature).

Once the safety thermostat has switched itself on, the device will be turned off.

When the device has cooled down sufficiently, the heating will be switched back on.

Investigate the cause of overheating.

If the safety thermostat does not switch in the event of overheating, the overheating protection will be tripped. In that case the device switches off completely. If so, please contact the customer service to have the overheating protection replaced.

# Information about the device

# **Device description**

The convector TCH 2310 E / TCH 2311 E is used to generate warm air for interior spaces.

The device generates heat by means of an electric heating element. The air surrounding the heating element is heated. The heated air rises through the air outlet and thus creates a natural suction that makes the cold room air flow into the device.

In addition, the device is equipped with a fan serving for a faster distribution of the heated air.

The device is equipped with an integrated temperature sensor which controls the heating depending on the current and the desired room temperature.

Via the control panel integrated in the housing you can set a target temperature value between 5 °C and 37 °C.

Moreover, the device is equipped with a remote control that can be used for controlling all functions and settings.


The integrated timer makes it possible to switch the device off with time delay.


The devices are not protected against water (IP20 type of protection).

The functioning of the two devices is identical, they merely differ in appearance or to be precise in colour: The device TCH 2310 E comes in white colour, the TCH 2311 E is black.

# **Transport and storage**

#### **Notice**

If you store or transport the device improperly, the device may be damaged.

Note the information regarding transport and storage of the device.

# **Transport**

To make the device easier to transport, it is fitted with a carry handle.

**Before** transporting the device, observe the following:

- Switch the device off.
- Hold onto the mains plug while pulling the power cable out of the mains socket.
- Do not use the power cable to drag the device.
- Allow the device to cool down sufficiently.

# **Storage**

**Before** storing the device, proceed as follows:

- Switch off the device.
- Hold onto the mains plug while pulling the power cable out of the mains socket.
- Allow the device to cool down sufficiently.

When the device is not being used, observe the following storage conditions:

- Store the device in a dry location and protected from frost and heat.
- Store the device in an upright position where it is protected from dust and direct sunlight.
- If required, use a cover to protect the device from invasive dust.
- Place no further devices or objects on top of the device to prevent it from being damaged.
- Remove the batteries from the remote control.



# **Assembly and start-up**

# Scope of delivery

- 1 x Convector
- 1 x Remote control (without batteries)
- 2 x Foot
- 4 x Screw (for foot)
- 1 x Manual

# **Unpacking the device**

- 1. Open the cardboard box and take the device out.
- 2. Completely remove the packaging.
- 3. Fully unwind the power cable. Make sure that the power cable is not damaged and that you do not damage it during unwinding.


## Warning

Risk of fire due to improper installation! There is a risk of fire if the required minimum distances are not observed.

Observe the "Installation" section in the "Assembly and start-up" chapter and the technical data in the "Technical annex" chapter.

# Feet assembly

- 1. Place the device on a table or on the packaging board with the short side pointing down.
- 2. Fasten both feet with two screws each.



- 3. Check the feet for tight fit.
- 4. Set the device up in an upright and stable position.


#### Start-up



#### Info

Odours might arise upon initial start-up or after a longer period of non-use.

When positioning the device, observe the minimum distance from walls or other objects as described in the chapter Technical annex.



- Before starting the device, check the condition of the power cable. If there are doubts as to their sound condition, contact the customer service.
- Set the device up in an upright and stable position.
- Do not create tripping hazards when laying the power cable or other electric cables, especially when positioning the device in the middle of the room. Use cable bridges.
- Make sure that extension cables are completely unrolled.
- Make sure that no curtains or other objects interfere with the air flow.
- Do not position the device directly below a wall socket.
- Make sure that the device cannot come into contact with moisture or water.



# Inserting batteries into the remote control



# Warning of electrical voltage

Do not touch the battery compartment with wet or damp hands.

# **Notice**

Do not use rechargeable batteries! Observe the Technical data for start-up.

- 1. Press the battery cover at the rear of the battery compartment and pull the battery cover out of the remote control.
- 2. Insert a CR 2023 battery into the battery compartment adhering to the correct polarity.
- 3. Slide the battery cover back into the remote control.


# Connecting the power cable

- Insert the mains plug into a properly fused mains socket.
- Make sure that the power cable is guided along the back of the device. Never guide the power cable along the front of the device!

Avoid open doors and windows.






# Info

The indication comes with a background illumination. The background illumination switches on as soon as one of the control panel buttons or the remote control is pressed. After approx. 1 minute without any actuation, the background illumination switches back off.

# Remote control

All settings of the device can also be made using the remote control included in the scope of delivery.

### Switching the device on

Once you have completely installed the device as described in the chapter Assembly and start-up, you can switch it on.

- 1. Set the On/off switch (1) to position I.
  - ⇒ The device is now in standby mode.
- 2. Press the On / Standby button (10).
  - ⇒ The device is switched on.

#### Setting the operating mode

The device has the following operating modes:

- Heating mode
- Frost monitor mode

### Adjusting the heating mode

- 1. Press the *Mode* button (13) until the desired heating level is selected. You can choose from three different levels.
  - ⇒ The selected performance level (20) is indicated on the segment display.

#### Frost monitor mode

In frost monitor mode the device heats automatically. This temperature cannot be changed.

- 1. Press the *Mode* button (13) until the *Frost monitor* indication (21) is displayed.
  - ⇒ The device heats automatically if the temperature falls below 5 °C.

#### Setting the desired room temperature

The room temperature determined by the temperature sensor is displayed on the *Current temperature* indication (19). You can set the desired room temperature at any time.

Setting the room temperature is only possible in heating mode.

The room temperature is preset to 25 °C.

- Press the arrow button increase value (15) or decrease value (16) to adjust the desired room temperature. Setting is possible in the range between 5 °C and 37 °C in increments of 1 °C.
  - ⇒ The set room temperature is displayed in the *Target temperature* indication (23).



#### Info

The desired room temperature should be higher than the current room temperature.

#### Fan only

- 1. Press the *Ventilation* button (14) to switch on the fan.
  - ⇒ The *Ventilation* indication (22) appears.
- 2. Press the *Ventilation* button (14) to switch off the fan.
  - ⇒ The *Ventilation* indication (22) disappears.

### Setting the timer

The timer has the following functionality:

 automatic switch-off upon expiry of a preset number of hours.

The number of hours to be set can be between 1 and 24 and is adjustable in increments of 1 hour. If the timer is activated, the time is also displayed in minutes.

#### **Notice**

The device must not be left unattended in a freely accessible room with an activated timer.

#### **Automatic switch-off**

- ✓ The device is switched on.
- 1. Press the *Timer* button (17).
- 2. Select the *Timer* button (17) to select the desired number of hours. The value range is between 1 and 24.
  - ⇒ The number of hours flashes on the *Timer* indication (18).
  - ⇒ The desired time until automatic switch-off is saved as soon as the *Timer* (18) indication stops flashing.
  - ⇒ The time left until switch-off is displayed in the *Timer* indication (18) and counted down.
  - ⇒ The device will switch to standby mode.

Note regarding automatic switch-off:

- Manually switching the device off disables the automatic switch-off function.
- If you select 0 hours, the timer will be switched off.

## Shutdown



#### Warning of electrical voltage

Do not touch the mains plug with wet or damp hands.

- 1. Switch the device off by setting the mains switch to position **0**.
- 2. Hold onto the mains plug while pulling the power cable out of the mains socket.
- 3. Allow the device to cool down sufficiently.
- 4. Clean the device according to the Maintenance chapter.
- 5. Store the device according to the Storage chapter.



# **Errors and faults**



#### Warning of electrical voltage

Tasks which require the device to be opened must only be carried out by authorised specialist companies or by the manufacturer.

#### **Notice**

Wait for at least 3 minutes after maintenance and repair work. Only then switch the device back on.

The device has been checked for proper functioning several times during production. If malfunctions occur nonetheless, check the device according to the following list.

#### The device does not start:

- Check the power connection.
- Check the power cable and mains plug for damage. If you notice damages, do not try to take the device back into operation.

If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.

Check the on-site fusing.

# The device is switched on, but the heating is not operating:

- The heating resistor might have blown. Have a defective heating resistor replaced by a specialist electrical company.
- The room thermostat might be defective. Have a defective room thermostat replaced by a specialist electrical company.

#### The air current is reduced:

 Check the air inlet and outlet. Make sure that air inlet and outlet are not obstructed. Remove any dirt. Observe the minimum distance from walls or other objects according to the technical data.

#### The device does not respond to the infrared remote control:

- Check whether the distance between remote control and device is too large and reduce it if necessary.
- Make sure there are no obstacles, such as furniture or walls, between the device and the remote control. Ensure visual contact between device and remote control.
- Check the charging status of the batteries and change them if required.
- If the batteries have just been changed, check them for correct polarity.

# The device still does not operate correctly after these checks:

Please contact the customer service. If necessary, bring the device to an authorised specialist electrical company or to the manufacturer for repair.

# **Activities required before starting maintenance**



#### Warning of electrical voltage

Do not touch the mains plug with wet or damp hands.

- Switch the device off.
- Hold onto the mains plug while pulling the power cable out of the mains socket.
- Allow the device to cool down completely.

# Cleaning the housing



#### **Warning of electrical voltage**

Never immerse the device in water!

Clean the housing with a soft, damp and lint-free cloth. Make sure that no moisture enters the housing. Protect electrical components from moisture. Do not use any aggressive cleaning agents such as cleaning sprays, solvents, alcohol-based or abrasive cleaners to dampen the cloth.

Wipe the housing dry after cleaning.
